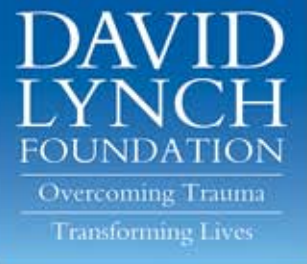

Gift Aid is a scheme run by HM Revenue and Customs that allows charities to reclaim the tax on donations by UK taxpayers. Using Gift Aid means that we get an extra 25% from the Inland Revenue helping your donation go further.
